

Contest Information:

- 1. BBQ sauces only. No spices, rubs, marinades, etc.
- 2. There are two contest divisions: Bottled & People's Choice
- 3. The Bottled Contest will consist of the following categories: Tomato (mild), Tomato (spicy), Vinegar (mild), Vinegar (spicy), Mustard (mild), Mustard (spicy), Fruit, and Miscellaneous. Each sauce entered may be entered in one category only. If any category receives an insufficient number of entries, we reserve the right to move the sauce(s) in said category to the Miscellaneous category. Sauces in the Bottled Contest will be judged blindly by a panel of judges on a date and location separate from the date and location of the festival. Each category will be judged by a different panel of judges. The judges may taste the sauce alone and/or with crackers/bread/meat.. Category winners will be judged blindly against one another to determine an overall winner for the Bottled Contest.
- 4. The People's Choice Contest will be comprised of the sauces (fresh and bottled) served at festival booths. Event attendees will choose the People's Choice Contest winner from among all sauces served at festival booths. All fresh sauces entered in the People's Choice Contest must either (a) be prepared on site on the day of the event or (b) be brought fresh to the event in sealed containers (e.g. sample cups with lids), in accordance with Austin/Travis County Health & Human Services Department food-permit regulations (which will be provided to you).
- 5. All sauces entered must be sold or served commercially (i.e. in a restaurant, by a catering company, by a sauce vendor). No homemade/personal sauces are eligible.
- 6. All Bottled Contest sauces must be delivered to us by Wednesday, October 12, 2016. The expiration date of each sauce must be later than the day of the contest (Sunday, October 16, 2016). At least 16 ounces of each sauce must be entered. No entries will be returned. If you send more bottles than we need for the contest, we will use the extra bottle(s) as a door prize. - 7. Entry fees may be paid by check (payable to Man Up Texas BBQ, LLC). Full payment must be received by Wednesday, October 12, 2016.
